Museum Collections & Exhibitions: In 2024 the Museum continued to explore Jewish culture and civic engagement in the Nation's capital. It expanded its archival collections significantly, which currently includes 1,566 objects, 40,000+ photographs, and over 1,000 linear feet of archival material, by connecting with community members and collecting artifacts, photographs, and documents, preserving them for posterity and broadening the stories the Museum can tell about the Washington Jewish experience. The museum presented two traveling exhibitions, "I'll Have What She's Having": The Jewish Deli and JewCE: The Jewish Comics Experience, which our curators enhanced with stories and artifacts from the Washington region. Nearly 23,000 visitors explored the Museum in 2024.

Public & Educational Programs: We engage Jewish and non-Jewish adults, families, schools, and students in programs and events throughout the region, including tours, panel discussions, school visits, community-building events, lectures, and workshops. In 2024, we have hosted nearly 900 students on school tours and more than 6,800 individuals for programs and events.
