The Museum completed architectural design with SmithGroup architects and obtained required zoning, historic preservation, and approvals from the Advisory Neighborhood Commission, Historic Preservation Review Board, and District of Columbia government. We began designing our exhibition and public spaces with the team of Evidence Design and Potion media.

Public Programs The Museum engaged more than 2,400 adults and students from 16 schools in educational programs throughout the region, including walking tours, lectures, panel discussions, and workshops. We partnered with 60 synagogues, schools and cultural organizations; acquired new collections to support our exhibition plans, and answered more than 40 research requests.

The Capital Jewish Museum explores the past, present and future of Jewish life in the nation's capital to inspire audiences to connect, reflect and act: connect across families and diverse communities, reflect on the relevance of history to today, and act on behalf of their communities and values.

The Museum was incorporated in 1965 as the Jewish Historical Society of Greater Washington, a nonprofit dedicated to preserving Jewish history in the Washington area. In 1969, galvanized by the pending demolition of the oldest synagogue in the nation's capital, the Society mobilized the community and saved the city's oldest synagogue building by moving it three blocks to the corner of Third & G Streets, NW. After restoration, the synagogue, listed on the National Register for Historic Places and DC Inventory of Historic Sites, was opened to the public and has been maintained as a site for visitors to experience Jewish history through archival collections, exhibits, and educational programs.

In 2018, the JHSGW adopted the new name of the Lillian & Albert Small Capital Jewish Museum as the organization prepares to build and launch a new public museum. In January 2019, the historic synagogue was moved as part of the massive Capitol Crossing development to the corner of Third & F Streets, where it will become the centerpiece of our new museum.

The new Capital Jewish Museum will inspire visitors to connect, reflect and act: connect across families and diverse communities, reflect on the relevance of the past to today, and act on behalf of their communities and values. Currently, the Museum is completing architectural designs with SmithGroup architectural firm and developing the exhibition and experiential plans for the new Museum. Although the historic synagogue is closed during the construction process, the Museum continues to engage the public through a variety of educational programs, walking tours, lectures, school programs, and other activities. The Museum's collections of historic artifacts, photographs, documents, and oral histories continue to grow and are accessible for researchers in the community and around the world.
